### You Have A Tumor!

"You have a tumor," said Dr. Al-Ali. WHAT? "And, we'll need to set up a time for an operation." WHAT? "Then we will know whether you'll need further treatment." WHAT? I was more incredulous than shocked by this news, because I've made it through life without a single serious medical problem.

Overnight, Northumberland Hills Hospital became important to me. I asked others about their experience with the hospital, the surgeons, the nurses, and asked around as to who were the best anesthetists (loss of control is big to me). Is the hospital as good as a city hospital? (As if I would know!) I feel a sense of shame that I had such silly and baseless notions about our hospital's competence.

My operation was a success. During my 2-night stay, I observed the antics of other patients, and paid particular attention to the nursing staff. On our floor, there happened to be a patient that caused so much strife – day and night. Yet the nursing staff showed only compassion and a remarkable patience towards this man. During the day, I walked the corridors and for the first time in my life, realized how very, very, lucky I am. I saw some very ill patients and others in stages of dementia, some far too young to be

there, and others without much hope of ever getting better.

Over the past year, I often think how very fortunate we are to live in this County and have such a fantastic facility. I often think of those hard-working, kind and caring nurses, the doctors, and the myriad of volunteers who make the hospital work.

There is always a need to adapt, change and grow with the demands and pressure of a changing population. I'm now clear. I'm fully committed to support this facility how and where I can. I want my hospital to be there when I need it.

When Ed Novinka passed away in December, 2017, his family named the NHH Foundation as a recipient of donations in his memory. Friends and family responded and over


\$1,000 in donations were received in his name. Over and above this, we were recently honoured to receive a personal donation from Ed's wife, Dorothy.

Thanks to the generosity of the Novinka family, several purchases will be made, including two AutoPap units, a glidescope, and rapid infuser. In addition to this, the Ed and Dorothy Novinka Endowment Fund will be created to provide an annual gift to the hospital in perpetuity.

After 50 years in the grocery industry and residing in Port Hope for over five decades, Ed's memory will live on through the care and comfort these gifts will provide to others.

#### The Ultimate Legacy

In the past year, we were fortunate to receive several gifts made through people's Wills, known as bequests. Every bequest, large or small, is critical in helping us in our relentless pursuit of investment in new medical equipment and technology to better serve Northumberland patients.

In October, we were able to announce the arrival of the new Canon Ultimax-1 flouroscopy unit and accompanying TIMS Medical digital recording system.

This \$1 million project was fully funded by the generosity of an anonymous bequest to the NHH Foundation. That's powerful!

"This new system makes it possible to perform multidirectional x-ray imaging and plays a critical role for the pain management of our patients with spinal and joint discomfort," says Ian Moffat, NHH's Director of Diagnostic Imaging and Laboratory Services. "Fluoroscopy allows for an area of the body to be filmed, and studied, in motion, rather than as a still, snapshot image. Think of it as a video, versus a photograph, and you can begin to get a sense of how powerful it can be from a diagnostic perspective!"

"Along with pain management, the new fluoroscopy unit and TIMS system has greatly improved our accuracy for swallow assessments. The TIMS unit is a digital recording device that captures images that helps to assess the patient's swallowing mechanism. This leads to better therapy to get our patients from the feeding tube to the dinner table faster," says Katie Beitle, Speech Language Pathologist at Northumberland Hills Hospital. "With this donation, we'll see a significant improvement in the quality of life for patients in our community."

"The new fluoroscopy unit is an excellent example of how one person's generosity has made a lasting impression on the care patients will receive for decades to come," says Adrienne Burns, Leadership Gifts Officer, NHH Foundation. "We are extremely grateful to this donor for thinking of NHH and are excited to see their legacy come to life to serve patients of west Northumberland."

#### **FAST FACTS ON ENDOWMENT**

#### **ASK AN EXPERT**

Members of our Planned Giving Committee are professionals working within our County in the areas of legal and financial matters. They have developed this list of questions frequently asked by their clients in the hopes this information may help you better understand your options:

#### Who should I choose as my estate trustee(s)?

You should ask someone that you trust and feel has the capabilities to perform the task required. You should discuss and consult with the individual(s) to confirm your mutual agreement on this important role. We suggest you discuss your decision with close family members if you would like them to know your reason for selecting a particular trustee. You should also name an alternate trustee(s) in case the person you name cannot act.

#### I don't have any nearby relatives or friends whom I want to "burden" with the task of Estate Trustee. Whom should I appoint?:

If there is not an appropriate and capable friend or relative within the province (or at least within Canada), you may be able to appoint a "corporate" Estate Trustee such as a Bank or Trust Company. However, a corporate trustee will usually require you to sign a fee agreement at the time of signing your Will and may not agree to be appointed as your estate trustee unless your assets have a certain minimum value. In some cases, your accountant or lawyer may be willing to be appointed in your Will as your Estate Trustee.

#### What are powers of attorney and do I need them?

Yes, everyone should have power of attorney. There are two kinds of powers of attorney: one for personal care (health); and one for property. With powers of attorney you can appoint someone you know well and trust to make medical and financial decisions for you while you are alive in the event you are unable to do.

#### Should I list specific items in my Will?

It is possible to list specific gifts for individuals, such as a piece of jewelry but there are other, more flexible, ways to deal with your "stuff" as well. A good solution is to reference in your Will a separate list of items that you will prepare and leave among your personal papers. This list gives the executor direction as to how to distribute your personal items among your beneficiaries. Although an executor would not be legally bound to do so, the executor would have a moral obligation to follow your wishes.

I want to leave funds to my favorite charity in my Will but I don't know how much to leave because I don't know how much money I will have at the time of my death, what do I do?

If we all knew the precise date of our deaths, estate planning would be much easier! However, given the uncertainty and the rising cost of long-term care, many people are unsure how much to leave to charity. A solution is to leave a percentage of the value of your estate. That way, the gift will always be proportionate to the size of your estate. This is a good way to ensure that you have left something for your family, while still remembering your favorite charity.

## NHH FOUNDATION PLANNED GIVING COMMITTEE

The Planned Giving Committee is an advisory working committee, providing guidance and support for the Northumberland Hills Hospital Foundation's gift planning endeavours and to act as advocates for the program.
